Council reviewed the report from the Benton County Sheriff's Office on calls from July 1, 2014 – December 31, 2014. Council thanked Mike Ferguson on behalf of the Benton County Sheriff's Office for all their efforts.

Benton County Chief Deputy Michael Ferguson shared the Benton County Clerk of Court used to process municipal citations through the system and pass them along to the cities. Since everything is done electronically now, the Clerk of Court will no longer be processing those citations. Ferguson shared that the City needs to update their code, create procedures for handling citation/appeals, and provide ticket books to the sheriff's office. Even though recodification of the City code is planned later this year, Council agreed this effort should be started as soon as possible.

Clerk shared a letter from Bob and Thelma Huffer with concerns for safety about hunting on the Benton County Conservation's land that adjoins the city limits and their property. Mayor Becker additionally shared concerns with gun hunting so close to walking trail and city limits. Benton County Supervisor Terry Hertle shared he had been the liaison to the Benton County Conservation Board and previously expressed concerns with the proximity of allowed hunting to the Pleasant Hill housing addition. His specific concerns were safety of children that live and play in or near the conservation. Public Works Director Jennings shared that Atkins had previously been managing the reserve, and Council did not want hunting so no hunting signs had been hung. A couple years back, the Conservation Board took back the management when a change in director occurred, and at that time, hunting started to be allowed on the conservation. Resident Sam Patterson asked if no target shooting signs can be put up out in that area since that is not allowed. Council expressed that tighter restrictions concern that something should be done before an incident occurred. Matt Purdy shared that he will put it on the agenda for the next Conservation Board meeting, which is on Monday, March 9th at 5:30pm at Benton County Nature Center.

Engineer Scott shared an update the Waste Water Treatment Facility Plan and Parkridge Road Sidewalk. She also shared her support in providing information on scope and capability for GIS services.

Korsmo shared that a request was raised about holding a farmer's market in the parking lot at the Library/ City Hall. He will work with the requestor to bring a proposal to Council.

On motion by Bishop, second by Harbach, voted to adjourn. Ayes: Bishop, Harbach, Herman, Korsmo, and Lynch. Nay: None. Motion carried. The next regular council meeting will be on Monday, March 2, 2015 at City Hall, 480 3rd Avenue, starting at 7:30 PM.
