Spading made a motion to have a discussion with Benton County Sheriff's. The Council wants to update them on traffic and traffic control concerns in Atkins. Robison seconded the motion. Ayes: Svejda, Rinderknecht, Spading and Robison. Nay: None. Absent: Shepard. Motion carried.

Mayor Visser updated the Council on the City of Atkins response to COVID -19 emergency.

Damon gave the Council an update on Public Works items.
