Council met in Special Session. Mayor Pro-Tem Rinderknecht called the meeting to order at 7:00 p.m. Present were Robison, Shepard, Rinderknecht. Svejda, and Spading. Also present was Tomlinson – Public Works, Kara Bullerman – City Attorney. Absent: Mayor Visser. Amber Bell – City Clerk. Public attending: Dick Lange and others present virtually.

Council discussed payroll services as part of the fill-in Clerk services. Rinderknecht reported Mayor has reported that payroll was completed today. Tomlinson reviewed the payroll dates for Council. No action taken.

Council discussed City Services billing (water bill) that would normally come out early December. Spading moved to direct the fill-in Clerk to process the water bill as soon as is possible and if that is not available, to send out estimated billing with a note the bill is estimated. Public input: Rinderknecht reported the City offices have moved to the trailers at Main City Park. Phone service is being monitored at the City Hall building but delays in answering may occur due to staff moving from City Hall to temporary trailers. Council also discussed damaged street light pole status. No action taken.
