Public Works Report: Mayor Visser informed the membranes for water treatment plant have been ordered.

Public Input: Krug discussed snow removal efforts in cul-de-sac and concerns regarding snowplows pushing snow in cul-de-sac on right-of-way sidewalk. Council discussed.
