Explanation of significant increases in the budget:

The City is adding a public works employee and two office employees to the payroll, increasing payroll and payroll benefit costs. After inadvertently removing the liability, property & self-insurance costs levy, the city is adding this levy back onto the tax rolls. The Derecho caused significant damage and expenses -FEMA and insurance are assisting with these costs; however, the City must front the costs to be reimbursed at a later time and in part.
