Stone Ridge Development 3rd Addition: Svejda introduced an ordinance entitled "Ordinance No. 224. An Ordinance Providing for the Division of Taxes Levied on Taxable Property in the Atkins Urban Renewal Area, Pursuant to Section 403.19 of the Code of Iowa." Svejda moved to approve the first consideration of Ordinance No. 224. Robison seconded. Ayes: Svejda, Robison, Rinderknecht, and Spading. Nays: None. Motion carried.

Stone Ridge Development 3rd Addition: Robison introduced Resolution 878 to set date for hearing on development agreement and tax increment payments to be August 2, 2021, at 7:00 p.m. Svejda seconded. Ayes: Rinderknecht, Svejda, Spading, and Robison. Nays: none. Motion carried.

Svejda moved to approve Resolution 879 a resolution upgrading the meter reading technology and software. Robison seconded. Ayes: Spading, Svejda, Rinderknecht, and Robison. Nays: none. Motion carried.

Spading moved to approve Resolution 884 setting wages for employees of the city of Atkins. Robison seconded. Ayes: Svejda, Rinderknecht, Robison, and Spading. Nays: none. Motion carried.

Svejda moved to approve Resolution 885 a resolution approving pay request No. 8 to Garling construction for Strom Damage repairs. Rinderknecht seconded. Ayes: Rinderknecht, Robison, Spading, and Svejda. Nays: none. Motion carried.

Rinderknecht moved to approve Resolution 886 a resolution approving the acceptance of IEDA Catalyst Grant for the 76 Main Avenue Project. Robison seconded. Ayes: Robison, Spading, Svejda, and Rinderknecht. Nays: none. Motion Carried.

Mayor Visser plans to post deputy clerk position. Notice will be posted at the post office, city hall, and paper. There has been no response from the other recruiters.

Mayor Visser gave public works department report. The TTHM levels have dropped below maximum levels allowed. City will still need to send a quarterly notice to citizens until the average of 4 quarters of test results is below maximum levels allowed. 2021 Street Maintenance has been completed. Park Trees have been removed. Working on cleaning ditches and maintenance upgrades to water plant.
