There being no written or oral comments for or against Mayor Visser closed hearing at 7:22 p.m. Svejda moved to approve resolution 897 approving proposed Budget Amendment No. 1 for FYE 2022. Spading seconded. Ayes: Spading, Svejda, Rinderknecht, DeMeulenaere, and Robison. Motion carried.

Robison moved to approve Resolution 898 Approving Alliant Staging Area Lease allowing Alliant Energy to use an area located at the Wastewater Treatment Plant. Spading seconded. Ayes: Svejda, Rinderknecht, DeMeulenaere, Robison, and Spading. Motion carried.

Ryan Tang City Attorney joined at 7:44 p.m.

Svejda moved to approve Resolution 899 approving proposed Commercial Incentive Agreement – Atkins Lumber. Robison seconded. Ayes: Rinderknecht, DeMeulenaere, Robison, Spading, and Svejda. Motion carried.

Robison moved to table Resolution 900 until the next regular city council meeting. DeMeulenaere seconded. Ayes: Robison, and DeMeulenaere. Nays: Spading, Svejda, and Rinderknecht. Motion failed. Demeulenaere moved to approve resolution by amending contract to be 12 months at \$70,000. Robison seconded. Ayes: DeMeulenaere, and Robison. Nays: Svejda, Spading, and Rinderknecht. Motion failed. Spading moved to approve Resolution 900 Approving City Administrator Employment Contract as it was presented. Svejda seconded. Ayes: Spading, Rinderknecht, and Svejda. Nays: Robison, and DeMeulenaere. Motion carried.

City Attorney Ryan Tang discussed the importance for a city to have guidelines regarding communications. Guidelines should include communications to vendors, professional service providers, social media, and media contacts. Tang discussed open records and open meetings.

Mayor's update: Beggar's Night will be observed October 31st. Fall Clean Up days will be October 23rd from 7 a.m. to 11 p.m. Deputy Clerk position is moving forward. Mayor gave update on storm recovery: Debris/Brush removal has reached insurance review stage with FEMA, Architect contract for Fire Station has been finalized, committee meetings will be bi-

weekly. Park fence has been rebuilt, working to finalize bid specifications for tree removal contracts, city has received insurance estimate to replace the Gazebo, a cost estimate has been received to upgrade temporary fire station door.

Mayor Visser gave public works update. Public works continues to remove dangerous limbs from right-of-way trees. Water Plant TTHM #s were within range for a 2nd quarter.

Public input: Various members of public spoke on various topics.

City Council workshop – Goal setting – budget FYE 2023 has been set for October 14, 2021, at 6 p.m.
