Svejda moved to approve the Consent Agenda items Spading seconded. Ayes Svejda, Rinderknecht, DeMeulenaere, and Spading. Motion Carried. Consent agenda was as follows Council Minutes of November 1, 2021 and the Engineer Report.

DeMeulenaere moved to approve Resolution 914 Approving Setting Salaries. Svejda seconded. Ayes: Rinderknecht, DeMeulenaere, Spading, and Svejda. Motion carried.

Svejda moved to approve Resolution 915 Approving Professional Service Related to Derecho Disaster for Debris Removal in Right of Way. Ayes: DeMeulenaere, Spading, Svejda, and Rinderknecht. Motion carried.

Svejda moved to approve Resolution 916 Approving Professional services related to Derecho Disaster for debris removal on City Owned Property. Spading seconded. Ayes: Spading, Svejda, Rinderknecht, and DeMeulenaere. Motion carried.

Council reviewed and discussed Solid Waste and Recycling rates and directed administrator to proceed with drafting ordinance to change rates.

Mayor's Visser announced Amy Breese the deputy clerk. Mayor gave update on Derecho recovery regarding the tree removal in right of way and city owned property, and the Gazebo.

Public Works update was given by Mayor Visser. Public Working on Snow Removal preparations, new signage continues, and new meter reading equipment is on order. The Public Works would like to remind citizens to keep all vehicles of streets and right of ways as snow is falling and for 72 hours after snow stops falling.
