Yard Waste Pickup

Runs **April through October**. Set your yard waste out <u>every</u> Wednesday. You may use yard waste bags, you can bundle sticks with string (not plastic or metal) or you can use your own container marked with a "Y". It must be under 40 lbs.

Next pickup is APRIL 27, 2022

From the Water Tower...

Did you know that a small leak can add up quickly?

A modern toilet takes 1-2 gallons per flush. If there is an internal leak in your toilet, it *could* lose up to 1/4 gallon of water per minute. Since there are 1,440 minutes per day, 1/4 gallon per minute could add up to 10,800 extra gallons of water used per day! Check your toilet for a leak if you have seen an increase in your monthly bill! It could be the culprit.

The water dept will start flushing hydrants when the weather gets nicer. Keep an on the city website for updates!



From Public Works...

We would like to thank the public for helping this winter by removing their vehicles from city streets during winter weather events. This allows city crews to better clean and widen streets as they plow. As warmer weather approaches maintenance activities will begin to pick up. Be Alert of Work zones.

- Expansion of the city soccer park trail creating a full half mile loop (including sidewalk along Parkridge Rd) and adding mile marker signage
- Upgrades to City Park ball field
- Addition of park amenities such as benches, new basketball hoops, permanent trash cans, dog waste stations, etc.
- Continue locating and raising water curb stops to improve ability to locate in the event of an emergency
- Continue upgrading of street signage.
- Ditch cleaning to help improve storm water runoff
- 2022 Street Maintenance to include crack sealing, chip sealing and concrete repairs. Map will be placed on City Website and Facebook page.
- Playground maintenance
- Trail maintenance

DEFINITIONS

Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

ppb -- parts per billion.

ppm -- parts per million.

pCi/L – picocuries per liter

N/A – Not applicable

ND -- Not detected

RAA - Running Annual Average

Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.

Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

SGL - Single Sample Result

RTCR - Revised Total Coliform Rule

NTU – Nephelometric Turbidity Units

GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. More information about contaminants or potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. ATKINS MUNICIPAL WATER WORKS is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Corrective Actions were taken. The City water is now in compliance with the TTHM.

SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the dolomite and limestone of the Silurian-Devonian aquifer. The Silurian-Devonian aquifer was determined to be slightly susceptible to contamination because the characteristics of the aquifer and overlying materials provide moderate protection from contaminants at the land surface. The Silurian-Devonian well will be slightly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources, and is available from the Water Operator at 319-446-7870.

See below. How to participate:

- 1. Review the list of items that will and will not be accepted.
- 2. Load your items in your vehicle and bring them up to the Fire Station Parking Lot.
- 3. You must bring help to unload your items.

Items accepted FREE of Charge:

- Furniture, mattress/box springs, sofas, chairs
- Lawn mowers (gasoline & oil must be removed)
- Scrap metal, bicycles
- Carpet (4' x 4' sections rolled & bundled)
- Large toys
- Swing sets (dismantled & under 4' in length)
- Flat screen TV Monitors (under 19")
- <u>Small</u> household printers

Items with a disposal fee: (cash/check ONLY)

- Computer monitors \$5
- TV/Monitors (larger than 20") \$5
- Appliances, small \$5, large \$10
- Large copiers, small \$5, large \$10
- Small LP gas tanks (20 lb. and under) \$5

Items NOT ACCEPTED:

- · Appliances that are filled with food
- Air conditioners
- Large propane tanks
- Tires
- Household recycling items
- Household garbage
- Yard waste/soil/tree stumps
- Construction materials of any kind
- Hazardous waste (gasoline, oil, oil filters, paints, solvents)
- Railroad ties
- Cardboard
- Items too large for one person to handle (or bring help)

Garbage And Recycling

To ensure our garbage and Recycling pickup goes smoothly

- All items must be within the provided cart.
- Items must be broken down in a manner that allows the lid to shut. Lid Must be Shut.
- Items outside provided cart will not be picked up

- Non-Recycling Items: NO Food or Liquids, No Foam Cups & Dishes etc., No Clothing, Furniture & Carpet, No Loose Plastic Bags, Styrofoam, Film or Bagged Recyclables.

<u>Accepted Recycling Items</u> Plastic Bottles & Containers, Food & Beverage Cans, Paper, Flattened Cardboard & Paperboard, Food & Beverage Cartons.
