Administrator's report: Fire station timelines for Construction Bid Letting and Bid Bond continue. Continues to finalize update to badger meter reading system. The city has been awarded 620K CDBG Housing grant. The Grant Agreement will be presented at the March 28th meeting.

Public input: A citizen concerned council is leaning toward making the same mistakes councils of the last 20 years have made by not planning/building for the future and being afraid to raise taxes/revenues.

A citizen asked how this will impact individual residents. Previous presentation on the website indicates levy impact based on taxable valuation prior to SF 181.
